

OFFICIAL RULES FOR THE “Watkins Glen International 2019 SportsCar Poster Giveaway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The Watkins Glen International 2019 SportsCar Poster Giveaway (“Sweepstakes”) begins on June 17, 2019 at 9:00 a.m. Eastern Standard Time (“EST”) and ends on June 27, 2019 at 11:59 p.m. EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: (1) Complete an official form online at www.theglen.com/postersweeps. Entries generated by script, macro or other automated means or by any means which subvert the entry process are void. Limit one (1) entry per person and per account, regardless of method of entry.
