

# OFFICIAL RULES FOR THE “Watkins Glen International Take the Pledge Sweepstakes”

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**SWEEPSTAKES PERIOD:** The Watkins Glen International Take the Pledge Sweepstakes (“Sweepstakes”) begins on April 12, 2021 at 11:00 a.m. Eastern Standard Time (“EST”) and ends on August 12, 2021 at 11:59 p.m. EST (the “Sweepstakes Period”).

**HOW TO ENTER:** During the Sweepstakes Period, there are two (2) ways to enter: (1) visit <https://www.theglen.com/take-the-pledge/> and follow the instructions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and email address on a 3" x 5" card and mail the card, with proper postage affixed to: The Watkins Glen International Take the Pledge Sweepstakes, 2790 County Route 16, Watkins Glen, New York 14891 to receive one (1) entry into the Sweepstakes. Limit one (1) entry per person and per email, regardless of method of entry. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor (as defined below) and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail. Incomplete, illegible, or fraudulent entries will be void.

**ELIGIBILITY:** Sweepstake is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction. Employees of Watkins Glen International, Inc. (“Sponsor”) and its parent, subsidiaries, limited liability and affiliated companies, and advertising and promotion agencies, and each of their respective family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside), and members of their households, whether or not related, are not eligible to enter or win. Sweepstakes is subject to all applicable federal, state and local laws. Void where prohibited by law.

Upon pick up, the winner and guest will each receive a swag bag. Upon arrival to the track, the winner and guest will receive a VIP tour and a Pace Car Ride. If

the winner provides an address outside of the 150 mile radius, winner may still receive tickets, swag bag, VIP tour and Pace Car Ride upon their arrival to Watkins Glen International, but shall be required to provide their own transportation to the racetrack property.
