

## Official Rules for the Cayuga Health Walking Trail Contest

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING**

**CONTEST PERIOD:** The Watkins Glen International, LLC (“WGI”) Cayuga Health Walking Trail Contest (“Contest”) begins and ends on the following dates and times (Eastern Standard Time “EST”) during the following Major Event Weekends held at WGI (the “Contest Period”):

- (1) IMSA WeatherTech SportsCar Championship Sahlen’s Six Hours of The Glen (“IMSA”):

Ends: Sunday, August 8, 2021 at 11:59 p.m. EST
  
- (3) Hilliard U.S. Vintage Grand Prix (“Vintage”)  
Thursday: September 9, 2021 at 12 a.m. EST  
Ends: Sunday, September 12, 2021 at 11:59 p.m. EST

**HOW TO ENTER:** During the Contest Period, there are two (2) ways to enter:

- (1) **In Person/ Online:** Participants will complete 3.4 mile walk during each Contest Period. Once completed the participant will visit the Contest landing page on [www.TheGlen.com](http://www.TheGlen.com) and fill out the entry form including: name, email, phone number, age, Contest Period attended, distance walked (in miles) and upload verification by submitting a photograph from participants preferred tracking app showing completion of the 2.0 miles (i.e., photograph or screenshot of fitness tracker, photograph selfie of participant on the walking trail near the mile marker sign or banner. Entries must be submitted by the following:
  - (i.) IMSA – July 8, 2021
  - (ii.) NASCAR – August 13, 2021
  - (iii.) Vintage – September 17, 2021
  
- (2) **Mail in Option:** Participants can download and print a filled out form, along with a photograph selfie and return their proof of completion of the 2.0 mile walking trail near the mile marker sign or banner. Entries must be submitted to Watkins Glen International, 2790 County Route 16, Watkins Glen, NY 14891 by the following:
  - (i.) IMSA – July 8, 2021
  - (ii.) NASCAR – August 13, 2021
  - (iii.) Vintage – September 17, 2021

Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, per method of entry. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor and will not be returned. Fraudulent entries will be void. By entering the Contest, you are providing your information to WGI.

**ELIGIBILITY:** Contest is open to legal residents of the fifty (50) United States and the District of Columbia, who are of the age of majority or older in the applicable jurisdiction.
