

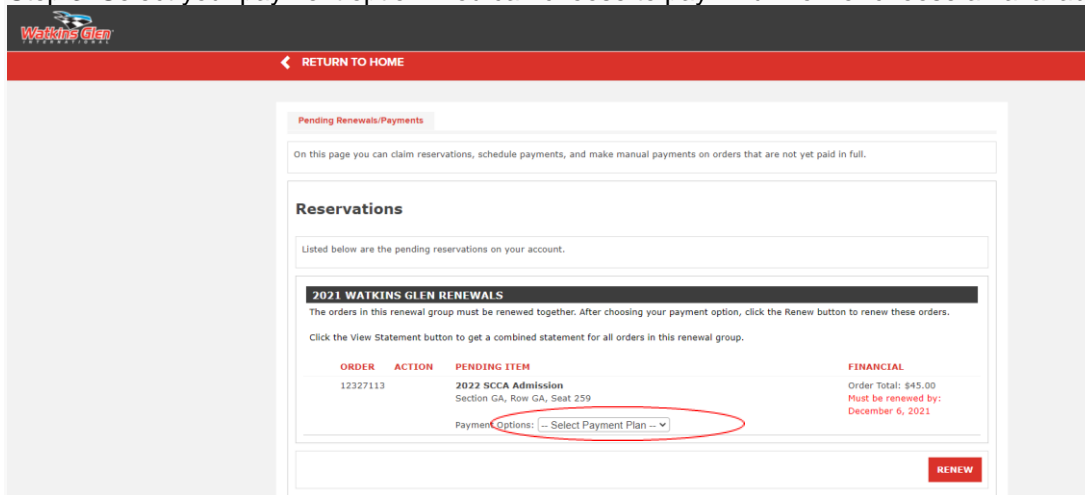

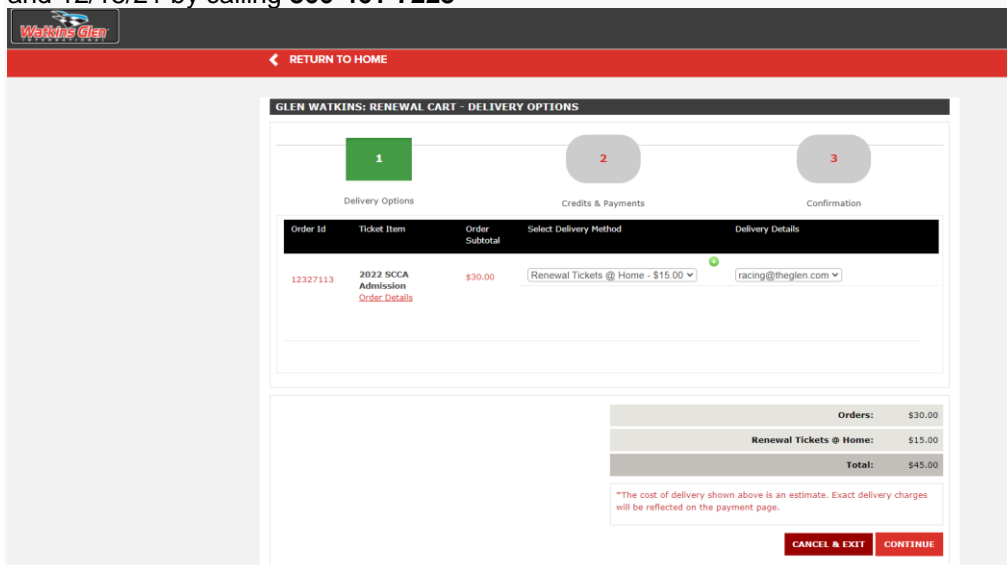
Step 2: Select Renew/Make Payments from the My Tickets Home Page

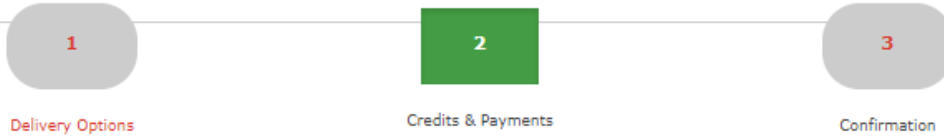
