

OFFICIAL RULES FOR THE “Watkins Glen International 2021 Renewal Sweepstakes”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The Watkins Glen International 2021 Renewal Sweepstakes (“Sweepstakes”) begins on November 09, 2020 at 9:00 a.m. Eastern Standard Time (“EST”) and ends on December 09, 2020 at 11:59 p.m. EST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there are two (2) ways to enter: (1) Renew your 2021 NASCAR Cup Series race tickets by phone at 866-461-7223 (RACE) or online at www.theglen.com or (2) Via Mail: Handprint your name, address, city, state, zip code, daytime and evening phone numbers (including area codes), and email address on a 3" x 5" card and mail the card, with proper postage affixed to: The Watkins Glen International 2021 Renewal Sweepstakes, 2790 County Route 16, Watkins Glen, New York 14891 to receive one (1) entry into the Sweepstakes. Limit one (1) entry per person and per account, regardless of method of entry. Entries received from any person in excess of the limitation will be void. All entries become the sole property of the Sponsor (as defined below) and will not be returned. Released Parties (as defined below) are not responsible for lost, late, stolen, garbled, incomplete, damaged, delayed, illegible, mutilated, misdirected, or postage-due entries or mail. Incomplete, illegible, or fraudulent entries will be void.

ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction.
